## Runyon Sports Complex Wall of Fame Selection Criteria

The following outlines the criteria for the categories that have been defined for the Runyon Sports Complex Wall of Fame. When completing the application, please keep these guidelines in mind to ensure that the submission meets the definitions.

To be considered for the current selection period, all applications must be received by Dec 1st of each year by the Runyon Board of Directors (selection committee).

The selection committee will consider all applications and render a final decision on or before Dec 15<sup>th</sup> of each year. The committee does not have to select any wall of fame candidates in any particular year. All Wall of Fame candidates will be considered by the committee and assessed according to the criteria as outlined.

- 1. Authorization: By authorization of the Board of Directors of the Runyon Sport Complex have authorized the wall of fame selection committee to hold an election every year for the purpose of electing members to the Runyon Sports Complex Wall of Fame.
- 2. Electors: Only active board members of the Runyon Sports Complex shall be eligible to vote.
- 3. An informal background review will be conducted by the Runyon Sports Complex staff for all finalists.
- 4. Eligible Nominees:
- 1. Player baseball or softball
  - a. Candidates must have played a minimum three years of baseball or softball at the complex
- 2. Administrator or past employee
  - a. Candidates in the category must have worked for the complex for a minimum of three years.
- 3. Board Members
  - a. Candidates in the category must have worked for the complex for a minimum of three years
- 4. Umpire, Announcer, or other game support personnel
  - a. Candidates in the category must have contributed to the programs or complex in some unique manner that would necessitate nomination.
- 5. Coach or Team
  - a. Candidates in the category must have contributed to the programs or complex in some unique manner that would necessitate nomination.
    - i. State Championships or other exemplary feats that recognized the programs or the complex
- 6. Community member
  - a. Candidates in the category must have contributed to the programs or complex in some unique manner that would necessitate nomination.

## Procedures:

- 1. An elector will vote for no more than five (5) eligible candidates deemed worthy of election. Absentee votes are not permitted. All board members in good standing are eligible electors. Electors must be present at the selection meeting in order to cast a vote.
- 2. Any candidate receiving votes on seventy-five percent (75%) of the ballots cast shall be elected to membership in the Wall of Fame.

## Runyon Sports Complex Wall of Fame Selection Criteria

- 3. Amendments: The Board of Directors of the Runyon Sports complex reserves the right to revoke, alter or amend these rules at any time.
- 4. If selected, the candidate grants permission to the Runyon Sports Complex Wall of Fame Selection Committee, to copy and photographs that are provided.
